- 4. Returns to the fire station after each call and assists in preparing equipment, supplies and apparatus for the next call for service.
- 5. Attends training sessions, business meetings, and work meetings.
- 6. Performs routine maintenance on equipment and apparatus in conformance with departmental policy.
- 7. Performs other duties as assigned.
